Consultation on the planned merger of Veritas Multi Academy Trust and Rainham Mark Education Trust

Dear valued Members, Trustees and Local Academy Committee (LAC) Governors,

We hope you are well and remain grateful for your continued efforts as we settle into the new term.

Further to the letter we shared in December, we wanted to provide an update on the exciting proposal to explore the possible merger between Veritas Multi Academy Trust and Rainham Mark Education Trust.

As shared previously, we believe the prospect of a merger presents a really positive opportunity for our trusts and schools. By coming together as two trusts, which will provide increased capacity and expertise, we strongly believe we can deliver even greater outcomes for our children and young people, staff and communities.

This includes working in increased collaboration to enhance our school improvement capabilities and to help drive forward our teaching excellence in classrooms, in order to deliver the very best educational provision to our students. Similarly, it will enhance the professional development opportunities we can offer, so we can continue to retain and recruit high-quality staff, and will help support the future sustainability and viability of our trusts and schools.

As the views and feedback of our school communities are hugely important to us, we have been hard at work developing a consultation through which you can express your views about the proposed merger. We are eager to hear your thoughts and perspectives as part of this process, particularly in relation to governance. The consultation will run from **Monday 3rd February** to **Thursday 6th March 2025**, and you can access it online here. We encourage you to respond to the consultation and look forward to hearing your feedback.
